Agenda Items:

1- The meeting minutes from November were approved.

- 2- Explanation of a new board member
 - A– Any member in good standing in an active club for the previous 12 month period.
 - B member must be nominated, someone must second nomination, and the nominee must accept the nomination.
 - C- Open board seat to be voted on at the general meeting 2/7/10 is for the Dan Kimmel vacancy, and is for the rest of that term until the April General membership meeting.
- 3-Vote on the new board seat procedures will be:

 - B- Ballots Read out Loud
 - C- Majority winner to take seat immediately

- 5- By-Law Vote discussion
 - A- Every President was e-mailed proposals more than 30 days prior to vote If they did no receive them, fix- e-mail address issue.
 - B- Each club will get one vote from President or representative, and each board member will get one vote.
 - C- Roll Call Vote 2/3 Majority needed to carry.
 - D- Eric Bond Proposal 1 13 no, 3 abstain motion failed
 - E- Eric Bond Proposal 2 13 no, 3 abstain motion failed
 - F- Eric Bond Proposal 3 -12 no, 4 abstain motion failed
 - G- Jack cahn Proposal 4 12 yes, 2 no, 2 abstain motion passes.
 - H- The passed by-law proposals from November and Feb will be updated to the website shortly.

6-Treasury Report.

- A- John Serniak presented a balance sheet with the total cash balance on hand as of 1/28/10
- B- Budget dollars already covered include conservation, youth, and State Team hotels and Jerseys for 2010. We are working on raising travel expense dollars for the junior members to the NGWJC in case money is cut from the travel vouchers. We are also working on travel money for the state team.
- C- Some prototype Solar Bat glasses are in, but not the TBF printed ones. The deal is the same with \$16 per pair, or 2 for \$30. Every pair your club sells they get \$1.00 in return for club activities and an extra \$10 for every 10 pairs sold.

- A- We will be purchasing the conservation project materials needed and setting up a March date for construction. We will need both Adult and youth help on this.
- B- We will be funding conservation officer Josh K to attend the National Conservation Conference in April.

- A- The MTCB will be hosting a meal at 4 PM through the registration meeting. The TBF will pay \$2/member.
- B- A motion was presented by Jeff Cox and seconded by Jack Cahn. The vote was 14 yes, 2 abstention to extend the free tournament registration deadline has been

- extended through 4/1/10 after the Grand Rapids show. The motion passed.
- C- The State Team will be made up of the top twelve anglers (top 6 will be boaters, next 6 co-anglers) and 13th place is the alternate. Each team member will have 5 nights hotel stay paid for (double occupancy with another state team member required) beginning 9/5/10 through 9/10/10.
