Each candidate spoke briefly on why they should be elected to the board.

Elections will be by roll call, with each club present getting 1 vote. Should there be a tie, the tie breaking process will be a commonly accepted method. The non-running board members (5) less the president will vote to break the tie.

Club dues must be fully paid prior to the April meeting to get full Voting and fishing rights for the 2009 season. A Ballot will be mailed and e-mailed to the club presidents and posted on the website shortly after 12/31/08.

After the April meeting vote, committees will be formed with a board member heading up each one. They will solicit additional membership (volunteers are encouraged) help to fulfill their deliverables for the upcoming season. These committees include, but are not limited to:

By-Laws

Currently there are some contradictions in the By-laws. In order to get these fixed, the current by-laws need to be voted on to change. By laws should be generic in nature, difficult to change, and opposing viewpoints heard. The details should be in our policies and procedures. A committee to address this will be put in place after the Board member vote in April. Proposed wording changes were submitted to the board, and will be voted upon at the April general membership meeting.

The current bylaws, and the proposed amendments, can be summarized as follows:

- 1. The board is currently required to meet regularly at least two times annually, plus one additional irregular meeting which is not followed by a general membership meeting. The first amendment will require the board to meet regularly at least three times annually, and allow for a general membership meeting to follow each of those meetings.
- 2. The adoption of amendments to the bylaws is currently permitted only during the April meeting. The second amendment will allow the adoption of amendments at any regularly scheduled meeting.

Per the bylaws, "Each club present at the April meeting will get one (1) vote, each board member will get one (1) vote. A 2/3 majority will be required for the motion to pass."

2009 Prize Money Disbursement

Northern Divisional

\$2000 minimum payout currently

80:20 split of prize winnings where:

20% - with a \$1000 minimum (\$500 ea) up to 20% total earmarked for the two state winners to attend the National Championship. Funds made up from general funds if payouts do not meet minimums set. Potential \$600 shortfall possible at minimum levels.

80% - \$150 expenses per boater paid from winnings (\$900 total)

The balance then split equally 13 ways (12 team members plus alternate) \$85 each @ minimum.
